Dear Clients, Partners, and Friends,

The results for South Ocean Management's Delaware LP, Kong Partners' L.P., before incentive fees, were as follows:

Partners' NAV for May was \$2.9773, after management fee, but before annual incentive fees of 15% on appreciation.

I am guessing, but last month was probably one of the worst on record (it certainly 'felt' that way: what is it about the month of May, anyway?). Overall, the decline over the month, as steep and fast as it arrived, was a needed and long overdue correction. Though we remain cautious, with 38% cash on the sidelines, we believe much pessimism is priced into the markets.

When the time comes, the Greater China region (with the Shanghai bourse down more than 20% year-to-date) should recover faster. Our holdings have averaged (over the past five years) a 19.4% return on equity, 18.2% return on capital and profit margins averaging 34.8%. The average price to cashflow for our holdings today is a low 5.8x and the price to tangible book value is 1.7x. Our weighted average price earnings ratio on this year's estimates is 6.0 times. Our long term debt to equity ratio is almost nil (less than 5% on average).

On the operational front, we have changed service providers. DBS (formerly, Development Bank of Singapore) is our new fund custodian. Apex Fund Services is our new administrator, who will work with each of our limited partners, calculating net asset valuations on their capital accounts. Apex will issue the first statement to our investors in July and will be contacting each of you by mail.
